You will receive a new to Moorpark folder pack, that contains all the key documents you need before your child starts in September (the staff at Jackfield will let you know when the packs are ready to collect from the school). Within this pack are your admission information documents, this includes all data collection sheets, consents for trips, local visits, internet use, photographs and also medical forms. There is also a free school meal application, term dates and uniform order sheet.

Please can you return all of the signed forms in the pack to Moorpark as soon as possible (before the end of the school year) – you can drop them in the office or return by post.













During this first week of school, in September, you will all have a Parentpay account set up at Moorpark so that all payments are completed online, this is for different items such as school dinners, educational visits, before and after school clubs.

Our school uniform will be available to purchase directly from our current supplier, Smart School Uniform. There is a shop is based in Newcastle – under-Lyme and they have recently opened one in Tunstall (follow the link or see the flyer in your pack). You can purchase directly online, using the link below and have it delivered to Moorpark or directly to your home, or you can visit the shop.

Please complete the free school meal application in the pack. We cannot assume that your child is entitled to free school meals, so if we don't have your application form back in time for September you will have to provide your child with sandwiches or you will be charged for a school lunch until we get authorisation.

Furthermore, we ask you to complete the form, even if you are planning for your child to have a packed lunch, as the school receives special funding for all children that are eligible for free school meals. This is known nationally as Pupil Premium and is currently around £1,345 per child. We use this money towards a variety of exciting learning experiences for all children and specific extra support.

The information in the pack is mostly for our office. Please go to the school website, Facebook and Twitter to see so much more about the different aspects of the school that are around the types of learning, different activities and photographs of the classrooms. You will hear and see lots more about the topics and lessons when you join one of the zooms.
