



New to Year 3 Intake Meetings

Dear Parent and Carers,

We would like to invite you to our new to Year 3 meeting for families of children transferring to Moorpark Junior School in September 2026.

The meetings will take place on

- Tuesday 16th June 2026 @ 2pm for **class 2N (3P)**
- Monday 22nd June 2026 @ 2pm for **class 2C (3B)**

If you are unable to make the meetings above for your child's class there will be another meeting which you are invited to attend.

This will take place on **Monday 22nd June 2026 @ 3.30pm**

The purpose of the meeting will be for parents and carers to meet the staff and to look around the school, in particular, the classrooms that your child will be in. You will also have time to ask any questions that you have to help your child's move to us to be as smooth as possible. Your child will have the opportunity to do the same when they visit, as part of our comprehensive and exciting transition program.

We will provide you with a welcome pack when we meet. The pack contains documents that you will need to complete and return to the school before September. There will also be an opportunity to view items for the school uniform during the induction meetings, you will order school uniform through our uniform provider, Smart School Uniform in store or on their website. We are hoping a 10% off new starter voucher will also be provided in your welcome pack.

Please apply for Free School Meals.

If you think you may be entitled to free school meals, we will also need the free school meal application form returning to us as soon as possible. Information in regards to Free School Meals, including the link to the application form has already been sent out to you at your previous school, however, all information in how to apply will be in your new starter packs. We cannot assume that your child is entitled to free school meals and the information is **not** transferred from your infant school so you will need to apply. If we don't have your application form back in time for September you will have to provide your child with sandwiches or you will be charged for a school lunch until we get authorisation.

Furthermore, we ask you to complete the form, even if you are planning for your child to have a packed lunch, as the school receives special funding for all children that are eligible for free school meals. This is known nationally as Pupil Premium and is currently around £1,550.00 per child. We use this money towards a variety of exciting learning experiences for all children and specific extra support.
